The USPEA will be offering the following types of Grants:

- **Equine Travel Grants** To be used to offset the travel expenses incurred for horse transportation.
- **Show Grants** To be used to offset specific competition expenses such as entry and/or stabling fees; purchase of shavings.
- Initial Classification Travel Grants To be used to offset the cost of travelling to and from a classification event for expenses such as air or train travel; gas, tolls, reasonable cost for lodging.
- All grants are subject to the approval of the USPEA Board of Directors and availability of funds.
- All grants will be awarded *after* completion of the event, pending the submission of the following:
 - 1) Proof of Participation;
 - 2) Expense Receipts specific to grants;
 - 3) Completed W9 form

Criteria For All Grants

To apply for any of the grants offered by the USPEA, the athlete must:

- 1) Be a current member of USPEA at time of application and event. (Apply for Membership at www.uspea.org).`
- 2) Be a United States citizen who has declared for the United States.
 - Athletes competing for another country do not qualify for USPEA grants.
- 3) Be at least 16 years old within the competition year.
- 4) Have a current USEF National or FEI International Classification with **Confirmed Grade** or **Review Set Date Status**.
 - Exception: Athletes applying for the JWM Initial Classification Grant only need to be eligible for classification. See details under grant descriptions
- 5) Complete a W-9 form at time of application.
- 6) Meet additional grant specific criteria as listed under each grant.
- 7) Apply for ONLY ONE grant at a time.
 - Additional grants may be applied for after determination and/or receipt of prior grant.
 - Maximum of two grants per year. One grant per each quarter year.
- 8) Submit completed grant application and all required documentation within three (3) months after the conclusion of an event.

USPEA Hope Hand Memorial (HHM) Grants

HHM#1 Domestic CPEDI1* Equine Travel Grant (Effective Jan 1, 2023)

Grant Specific Criterion:

HHM #1 Equine Travel Grants are being offered to athletes to who must transport their horses at least 250 miles, one way, to a U.S. CPEDI1* Event.

To apply for a HHM#1 Domestic CPEDI1* grant, the Athlete MUST:

- 1) Participate in three (3) shows; one of which may be virtual.
 - Acceptable "in-person" shows must be 2 different Licensed USDF/USEF Competitions, under two (2) different judges, held on two (2) different weekends.
 - Acceptable virtual show is the USPEA Virtual Judging Program.
- 2) Complete the Para-Dressage Tests Novice A AND Novice B in their classified grade.
- 3) Submit three (3) tests, each with a score of at least 64%.

- Domestic CPEDI1* Equine Travel Grants may be awarded a maximum of **ONCE** per year regardless of the number of horses being transported per athlete.
- Two (2) Grants is the Lifetime Maximum per athlete.
- Athletes that have competed in a CPEDI2* or CPEDI3* **DO NOT** qualify for the CPEDI1* grant.

Reimbursement is per the following criteria and is based on one-way mileage.

<u>HHM#2 – US Dressage Festival of Champions Equine Travel Grant (Effective Jan 1, 2023)</u>

HHM #2 Grants are being offered to emerging athletes to offset horse transportation expenses for those transporting their horse(s) at least 250 miles *one way* to the USEF Festival of Champions (https://www.usef.org/compete/disciplines/dressage/dressage-championships---national--fei/us-dressage-festival-of-champions).

To apply for the HHM#2 US Dressage Festival of Champions Equine Travel Grant, the Athlete MUST have:

- 1) Received an invitation from the USEF and competed in the US Dressage Festival of Champions, Para Dressage division.
- 2) Only competed in a CPEDI3* during the past 2 competition years in which they are applying for the grant, or never competed in a CPEDI3.
- Domestic Equine Travel Grants may be awarded a maximum of **ONCE** per year regardless of the number of horses being transported per athlete.
- Two (2) Grants is the Lifetime Maximum per athlete.

Reimbursement is per the following criteria and is based on **one-way** mileage.

 - 8) Expense Receipts for horse transportation or specific grant expenses;

JMW #1 - Emerging Athlete National Show Grant effective Jan 1, 2023

JMW #1 - Emerging Athlete National Show Grant

Grant Specific Criterion:

- The JWM#1 Emerging Athlete National Show Grant is to be used to offset the expense of participating in a National Dressage Show in FEI Para-Dressage Test of Choice (TOC) classes.
 - a. Grant is intended for only one show per weekend. Should more than one show be scheduled for the same place and weekend all shows will count as one.
- 2) Funds from this grant can be used to pay for such expenses as: entry and/or stabling fees; trainer fees.
- 3) Grants of \$350.00 may be awarded for up to two USDF/USEF competitions per calendar year.
- 4) Athletes who have competed in a CPEDI2* or CPEDI3* event are not eligible to apply for the JWM #1 Emerging Athlete National show Grant.
- 5) Athletes may only apply for one grant at a time.
- 6) Athletes may apply for a maximum of 2 (two) JWM#1 grants per calendar year.
- 7) Athletes may apply for a maximum of 4 (four) JWM#1 grants in their lifetime.

- Grants are awarded as long as funding remains available. In the case of over-subscription, athletes who have travelled the furthest distance and have submitted their first application of the year will be given priority over athletes who have received a previous Emerging Athlete National Show Grant.
- All grants will be awarded *after* completion of the event, pending the submission of the following:
 - 10) Proof of Participation;
 - 11) Expense Receipts for entry and/or stabling fees or trainer fees;
 - 12) Completed W9 form

USPEA JMW #2 - Initial Classification Travel Grant (Effective Jan 1, 2023)

- 1) JWM#2 Initial Classification Travel Grants are being offered to offset travel and lodging expenses incurred by athletes who are travelling more than 250 miles, one way, to attend their *initial (first)* classification event for rather it's:
 - a. A USEF National or
 - b. An FEI International Classification
- 2) Athlete must be eligible for classification according to the FEI Classification rules.

 - b. Specific eligibility information can be found on pages 11 & 12 (7. Eligible Impairment) and Appendix I & II.
 - c. <u>Important</u>: USEF follows the FEI classification rules for National Classification
- 3) The classification event must take place in the U.S.
- 4) Athlete must submit a two-year plan to compete in a USEF/USDF licensed competition.

Reimbursement is per the following criteria and is based on **one-way** mileage.

- The maximum reimbursement for airline flight or train travel is \$450.00.
- The maximum reimbursement for the hotel is \$250.00 for an athlete who is staying more than one night.
